5. Extensive tree plantation shall be carried out in open areas available within the factory premises and good house keeping practices shall be maintained.
6. Industry shall take adequate precautionary measures before and during operation, maintenance and cleaning of pollution control equipment to avoid any accidental hazard.
7. Industry shall submit environmental statement for the previous year ending 31<sup>st</sup> March on or before 30<sup>th</sup> September every year to the Board.
8. Industry shall make proper arrangement for the disposal of solid waste, also valid authorisation under Hazardous Waste (Management, Handling & Transboundary Movement) Rules, 2008 shall be obtained to the Board.
