5. Industry shall install necessary noise pollution control equipment like canopy/acoustic enclosures in D.G. Sets. The noise level remains less than 75 dB (A) during day time and 70 dB (A) during night time.
6. Industry shall comply with all the relevant acts/rules, directions, guidelines, notifications issued by MoEF/CPCB/MPPCB from time to time as required and, if applicable.
7. Industry shall submit a fresh application for next renewal of consent u/s 21 of Air (Prevention & Control of Pollution) Act, 1981 180 days before the expiry of the date of this consent renewal letter.

The application shall be made in prescribed application form with consent renewal fee along with report of compliance of consent conditions mentioned in original consent letter and its subsequent consent renewal letter.
