

4. Extensive tree plantation shall be carried out in open areas available within the factory premises and good house keeping practices shall be maintained. The yearwise plantation record shall be maintained and reported to the Board yearly.
5. Industry shall make proper arrangement for the disposal of solid waste, also valid authorisation under Hazardous Waste (Management, Handling & Transboundary Movement) Rules, 2008 shall be obtained from the Board.
6. Industry shall submit environmental statement for the previous year ending 31st March or before 30th September every year to the Board.
7. The consent/renewal license fee deposited by the industry is liable for revision, if at any point of time it is found necessary.
8. Industry shall comply with all the relevant acts/rules, directions, guidelines issued by MoEF/CPCB/MPPCB from time to time as required and, if applicable.
9. Industry shall submit a fresh application for next renewal of consent u/s 25/26 of Water (Prevention & Control of Pollution) Act, 1974, 180 days before the expiry of the date of this consent renewal letter.
The application shall be made in prescribed application form with consent renewal fee along with report of compliance of consent conditions mentioned in original consent letter and its subsequent consent renewal letter.
The consent renewal fee shall be payable as per latest gazettee notification dated: 07/10/09 in accordance with gross block mentioned.





The application shall be made in prescribed application form with consent renewal fee along with report of compliance of consent conditions mentioned in original consent letter and its subsequent consent renewal letter.




