भारत सरकार, पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय, नई दिल्ली द्वारा जारी प्लास्टिक अपशिष्ट प्रबंधन नियम, 2016 के प्रावधानों अनुसार प्रदेश में कार्यरत प्रोड्यूसर्स/ ब्राण्डओनर्स पर लागू ईपीआर की पूर्ति हेतु प्रोड्यूसर्स रिस्पांसिबिल्टी आर्गेनाईजेशन (पीआरओ) के रूप में कार्य करने हेतु संस्थाओं/ व्यक्तियों को सूचीबद्ध करने हेतु निर्धारित प्रारूप में आवेदन आमंत्रित किए जाते हैं। प्रदेश में कार्यरत ऐसी संस्थाएँ/ व्यक्ति जो प्लास्टिक अपशिष्ट संग्रहण एवं निष्पादन करने की इच्छा जाहिर करना चाहते हैं वे अपनी संस्था/ व्यक्ति की सम्पूर्ण योग्यता सहित विवरण मध्यप्रदेश प्रदूषण नियंत्रण बोर्ड मुख्यालय, पर्यावरण परिसर, ई-5, अरेरा कालोनी, भोपाल में भौतिक रूप से अथवा ई-मेल it_mppcb@rediffmail.com पर दिनांक 15/03/2020 तक प्रस्तुत कर सकते हैं। पीआरओ के लिये आवश्यक योग्यता/ सुविधाओं के संबंध में विस्तृत विवरण एवं आवेदन का प्रारूप मध्यप्रदेश प्रदूषण नियंत्रण बोर्ड की वेब-साईट www.mppcb.nic.in पर Wastemanagement/Plastic Waste Management/Preparation of Action Plan for PIBOs में देख सकते हैं।

प्रदेश में प्लास्टिक अपशिष्ट प्रबंधन नियम, 2016 के अन्तर्गत ईपीआर को प्रभावी ढ़ंग से लागू करने हेतु प्रोड्यूसर्स रिस्पांसिबिल्टी आर्गेनाईजेशन (पीआरओ) को सूचीबद्ध किया जाना है। ऐसी संस्थाएँ/ व्यक्ति जो प्रदेश में प्लास्टिक अपशिष्ट संग्रहण एवं निष्पादन करने के कार्यों में रूचि रखते हैं वे इस हेतु मध्यप्रदेश प्रदूषण नियंत्रण बोर्ड में दिनांक 15/03/2020 तक आवेदन कर सकते हैं। प्रदेश में पीआरओ के रूप में काम करने हेतु निम्नलिखित योग्यताएँ/ सुविधाएँ आवश्यक हैं:-

- मध्यप्रदेश के विभिन्न जिलों में कार्य करने को सहमत हों, संस्था/ व्यक्ति किस जिले में कार्य करने का इच्छुक है इसका स्पष्ट उल्लेख आवेदन में किया जाये।
- 2. एकत्रित किये गये प्लास्टिक अपशिष्ट के भंडारण व उसके प्रसंस्करण की सुविधा हेतु कलेक्शन सेन्टर उपलब्ध हों।
- 3. प्लास्टिक अपशिष्ट संग्रहण हेतु वेस्ट पिकर्स पंजीकृत हों अथवा इस तरह की किसी संस्था के साथ अनुबंध हों, जो इस क्षेत्र में कार्यरत है।
- 4. सार्वजिनक स्थलों, रेल्वे लाईन के किनारे/ शहरों के बाहरी क्षेत्रों में उपलब्ध सभी तरह का प्लास्टिक अपशिष्ट एकत्रित करने की सुविधा हो।
- 5. प्लास्टिक चक्रीकरण करने की सुविधा अथवा किसी चक्रीकरण संस्थान के साथ अनुबंध हो, चक्रीकरण नहीं होने के लायक प्लास्टिक अपशिष्ट के निष्पादन हेतु किसी सीमेंट उद्योग/ सड़क निर्माता संस्था से अनुबंध हो।
- 6. उपरोक्त सुविधाओं के साथ-साथ संस्था/ व्यक्ति संलग्न कार्ययोजना के संलग्न-॥ में उल्लेखित विवरण की पूर्ति हेतु सक्षम हो।

PREPARATION OF ACTION PLAN FOR PRODUCERS/ IMPORTERS/ BRAND OWNERS (PIBOS) FOR PLASTIC WASTE MANAGEMENT

1.0 Background:

Plastic Waste Management(PWM) Rules 2016 provide a regulatory frame work for management of plastic waste generated in the country. The provisions of these Rules lay emphasise on plastic waste minimization, source segregation, recycling, involving waste pickers, recyclers and waste processors in collection of plastic waste fraction either from households or any other source of its generation or intermediate material recovery facility and adopt polluter's pay principle for the sustainability of the waste management system.

As per the provisions of the PWM Rules the PIBOs have to work out modalities for waste collection system based on Extended Producers Responsibility (EPR). EPR means the responsibility of a producer (includes Brand-owners/Importers) for the environmentally sound management of the product until the end of its life. Further the PIBOs are required to obtain Registration from CPCB/ SPCBs (as the case may be) prior to commencement of production. The PIBOs are required to apply for Registration in Form I along with the Action Plan for plastic waste management. This document gives the outline for framing the Action Plan for plastic waste management(PWM) by PIBOs.

2.0 Alternatives for Action Plan

The following alternatives may be considered for preparation of action plan for PWM:

(i) Plastic Waste management through Own Distribution channels-

- waste Collection: Through own distribution channel.
- b. Waste Quantity: Waste quantity should be equivalent to the estimated quantity of plastic waste generated.
- c. Waste Recycling: In this case, the PIBOs Owner must have contract with the recyclers to ensure that the waste collected by them is sent to the recyclers. Alternatively, the PIBOs can send the plastic waste for co-processing in cement mills. Road making or any other waste processing facility, the documentary proof of which has to be submitted to CPCB.
- d. Action Plan Coverage: To cover the area in which the products are sold to ensure collection of plastic waste preferably in the states/UT covered by their distribution

- (ii) <u>Plastic Waste management through Urban Local Bodies(ULBs)</u>: The PIBOs can engage with the ULBs for collection, segregation and recycling of equivalent quantity of plastic waste.
 - a) Waste Collection: In partnership with ULBs.
 - b) Waste Quantity: Waste quantity should be equivalent to the estimated quantity of plastic waste generated.
 - c) Waste Recycling: In this case, the PIBOs/ULBs may have contract with the recyclers to ensure that the waste collected by them is sent to the recyclers. Alternatively, the plastic waste can be sent for co- processing in cement mills/ Road making or any other waste processing facility, the documentary proof of which has to be submitted to MPPCB.
 - d) Action Plan Coverage: To ensure Statewise coverage, preferably one ULB from each of the five zones of India i.e North, South, Central, East and West India may be engaged by PIBOs selling their products on Pan-India basis. For those PIBOs selling their products in a limited no. of States/UTs – ULBs may be engaged so as to ensure maximum coverage of States/UTs. Also, to ensure that cities of all categories are covered preferably one ULB from Tier I, II & III be engaged.
- (iii) Through Agency: The PIBOs may prepare their Extended Producers Responsibility Plan through any other agency working in this field in the State. The agency interested to work as Producer Responsibility Organisation (PRO) in the State of Madhya Pradesh must have necessary arrangements for collection & segregation of waste and recycling of the waste. Other requirements of this alternative shall be same as "ii" above.
 - a) Waste Collection: Proper network of the waste collectors or partnership with any other agencies working in this field.
 - b) Waste Quantity: The Plastic Waste quantity should be equivalent to the estimated quantity of plastic waste generated by the Producer/Brand Owner/Importer.
 - c) Waste Recycling: In this case, the PIBOs/PRO agencies may have contacts with the recyclers to ensure that the waste collected by them is sent to the recyclers. Alternatively, the plastic waste can be sent for co- processing in cement mills/ Road making or any other waste processing facility, the documentary proof of which has to be submitted to MPPCB.
 - d) Action Plan Coverage: To ensure statewise coverage, may be engaged by PIBOs selling their products in the State. Also, to ensure that all categories cities of the State to be covered.

PIBOs may consider any or a combination of the above alternatives for preparation of the Action plan. In addition to the above three alternatives, PIBOs may submit the Action Plan following any other option which is feasible and ensures management of plastic waste management in accordance with provisions of PWM Rules.

3.0 Implementation and Monitoring Plan:

- (i) PIBOs need to submit verification process in case of engagement of Agency to confirm that said quantity of waste has been managed by the Agency and there is no overlap / duplication with other PIBOs.
- (ii) The Action Plan submitted by PIBOs shall provide to the Board for confirmation.
- (iii) The PIBOs to submit the details of waste collected through either of the three options in 2.0 above and submit it to Board on quarterly basis. Format of submission of quarterly report is enclosed at Annexure II.

4.0 Validation of Information submitted by PIBOs

- (i) The PIBOs shall be solely responsible for the information provided to Board.
- (i) The Extended Producers Responsibility Organisation shall also submit quarterly information to the Board regarding the waste collection and its disposal with detail of recycler, cement industry or any other agency taking responsibility of waste disposal in format-III.
- (i) If, at any stage, information provided by the PIBOs is found to be incorrect, then the Registration granted by CPCB shall be cancelled.

Format for framing Action plan for PWM incorporating the above points is placed at Annexure I. Format for Submitting Quarterly Reports on PWM by PIBOs to MPPCB is enclosed at Annexure II.
